Pursuant to Article III. Section 4 (c) of the Jackson Electric Cooperative Bylaws: "Nominations for candidates for director to represent each district shall be made by petition signed by not less than ten (10) members eligible to vote in the district to be represented by the candidate and delivered to the principal office of JEC at least thirty (30) days prior to the district meeting. Nominations from the floor at the district meetings will not be permitted unless there is no qualified nominee by petition who is able and willing to serve as a director."

Nomination packets can be obtained at Jackson Electric's office. Please contact our office to schedule an appointment to pick up your packet. Candidates are subject to a background check. The documents included in the nomination packet must be completed in their entirety and received at Jackson Electric's office no later than 4:00 p.m. on Monday, April 5, 2021.

Virtual district meetings will be held in Districts 4, 5, and

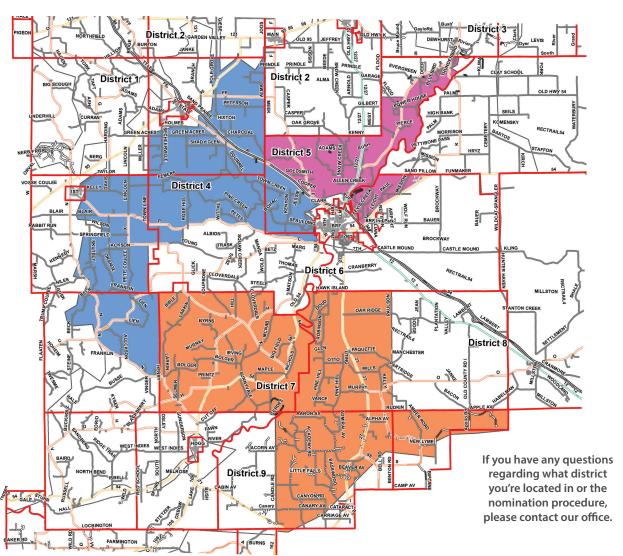
7, and voting will be conducted with a mail-in ballot. Members who have a meter in each of these districts will receive a meeting notice via USPS in June. The newly elected directors begin their terms following ratification at the annual meeting.

MARCH IS CSA MONTH!

At the height of the COVID-19 pandemic, the importance of farm-to-table producers became more evident with disruptions to our food supply. Remember the reality that you never would have imagined? Food shelves were bare. Refrigerator coolers sat empty. A simple run to the grocery store became a guessing game of which items would be in stock. Food insecurity is a scary thing, but it doesn't have to be that way.

If you're looking for food security and want locally sourced food, consider a subscription to a CSA (Community Supported Agriculture). In the simplest explanation, a CSA sells shares (think membership) to individuals in the community. By subscribing to a share, individuals are involved with the risks and benefits involved with production.

With a CSA, you are

buying an "at cost" subscription for the growing season. The risk may be a poor growing season, but the reward is a box of fresh produce that you can pick up at the farm or have delivered to your house, usually for an additional price. CSA products may be available weekly, monthly, or have a set number of pickups or deliveries throughout the season, which varies by the individual CSA.

You may be surprised to discover that some CSAs have "thought outside the produce box." Other CSAs may offer shares of farmfresh eggs, homemade bread, homegrown meat products, scrumptious Wisconsin cheese, and even flowers.

Qualifications. No member shall be eligible to become or remain a director or to hold any position of trust in JEC who:

- (1) does not have the capacity to enter into legally binding contracts, or
- (2) is not a bona fide resident in the area served by JEC, and of the particular district which he or she represents, or
- (3) is in any way employed by or financially interested in
 - (a) a competing enterprise, or
 - (b) a business selling electric energy or supplies to JEC,
- (4) is an employee of JEC, or
- (5) has any form of pending litigation which is, in any way, adverse to the interest of JEC, had participated in litigation or had some form of adversarial claim against JEC within ten years of nomination, election or appointment, or is likely to have an adversarial interest, claim or litigation against JEC during the term of his or her director position, or
- (6) while serving as a director or at any time within ten years preceding his or her nomination, election, or appointment was an employee of JEC, or
- (7) while serving as a director, or at any time within 15 years preceding his or her nomination, election or appointment, was convicted, or completed a sentence, probation or parole arising from conviction, of a felony or other offense involving dishonesty or breach of trust.

When a membership is held jointly, either joint member, but not both, shall be eligible to be a director, provided the candidate meets the qualifications set forth in (1) through (7), above, and provided further that the other joint member meets the qualifications in (3) through (7), above. When a membership is held by a corporation, partnership, or limited liability company, any one (but not more than one) of the officers, partners, or members shall be eligible, provided the candidate meets the qualifications set forth in (1) through (7), above, and provided further that all the officers, partners, or members meet the qualifications in (3) through (7), above.

Nothing in this section contained shall be construed to preclude any member from serving as a director or from holding any position of trust in JEC because such member is an incumbent of or candidate for the office of town chairman or supervisors or because such member is also a member or director of any other cooperative from which JEC purchases or may purchase electric energy, supplies or services, not shall anything in this section contained by deemed or construed to affect in any manner whatsoever the validity of any action taken at any meeting of the board of directors.
