

CHARGE UP AT WAZEE LAKE

General Manager's Message

BE PREPARED FOR THE LIGHTS TO GO OUT


he past several years, Jackson Electric has experienced what is known as Maximum Generation Warnings. When these warnings are issued, Jackson Electric prepares for potential system-wide power outages.

Annually, Jackson Electric participates in an emergency load reduction drill, administered by Dairyland Power, in which we determine which substations, circuits, and phases can be shut down when required to shed 25 percent of our load due to a shortage of generation resources. This is not new to our industry; however, it is taken more seriously now with the shutdown of generating resources, the high demand for electricity, and the intermittency of renewable energy.

Our power supplier, Dairyland Power, is a member of the Midcontinent Independent System Operator (MISO), which is the regional transmission organization that covers portions of the mid-section of the United States from Canada to Louisiana. Through MISO, Dairyland sells the power it generates and purchases power it needs for its members. If there is a high demand for electricity on the grid, MISO can issue Dairyland to reduce its load.

A warning is just that: warning that there may be a need to initiate load

reduction. However, we have experienced more of these warnings and are anticipating these warnings to advance to a Maximum Generation Event. It is our hope that MISO cancels the event before reaching this stage and that the price of electricity drops. If the event isn't canceled, Dairyland Power will signal receivers to shut down water heater elements, cooling systems, and eventually commercial loads will need to operate their generators. If this amount of load shedding does not relieve the demand on the grid, MISO may declare system-wide power outages to protect the integrity of the grid.



Declaration of this event will provide Jackson Electric minimal amount of time to put our load reduction plan into action and to notify members. The power outage can vary depending on power supply limitations.

If you have a medical need for which electricity is necessary to power equipment, we suggest you consider the purchase and installation of an automatic standby generator or have an alternate place to stay that has power during the event.

Because we will have little time to notify our members and to shed load, we practice our procedures to make sure we are as efficient as possible. Notifications of such an event will be placed on Jackson Electric's Facebook page and WWIS radio.

MANAGING THE DEMAND FOR ELECTRICITY

JACKSON ELECTRIC PREPARES FOR SUMMER PEAK ALERTS

n the hottest days of the year, there is a higher demand on the electrical grid. Cooling systems and other equipment work harder and run longer to maintain a set temperature. Our power supplier, Dairyland Power, carefully monitors this demand on the grid and the price to purchase electricity. If these don't balance, then Dairyland may issue an energy management event, otherwise known as a peak alert, or an economic control event may be issued if the price of electricity rises above its threshold.

If we go back to high school economics, we know that when supply is low and demand is high, prices increase. During times of high demand on the grid, energy prices increase. Energy management programs exist to keep energy rates at bay and balance on the power grid.

What residential devices are "interrupted" during an energy management event, and how are they managed? The simple answer is water heaters participating in Jackson Electric's water heater program and dual fuel cooling systems are interrupted during a summer peak alert. However, the times of interruption are



different. These loads are interrupted via an energy management receiver. This is the "gray box with lights" that is typically located outside your house by the meter or near your breaker panel. The diagram on the outside of the receiver shows you which lights to look for to determine if your water heater and/ or cooling system is being interrupted. When an energy management event is issued, a radio signal is sent to the receiver to interrupt the wired loads.

✓ I'm on Jackson Electric's water heater program, but I'm not on the dual fuel program.

Electric water heaters participating in Jackson Electric's water heater program are only interrupted during an energy management event. When a peak alert is issued during the summer, the heating elements on the water heater are interrupted, starting at 2 p.m. and restored by 8 p.m. You can still use hot water during this timeframe, but your elements won't be working to heat the cold water coming into the tank

during this time. You may run out of hot water if your tank isn't large enough to meet your needs during this period.

✓ I'm on Jackson Electric's dual fuel program.

Dual fuel water heaters have their own daily energy storage schedule because they receive the dual fuel rate for their usage. The water heater qualifies for this rate because the member has a minimum of 4 kW of electric heat installed and operational. The interruption schedule remains the same for dual fuel water heaters, regardless of a full load control. The summer schedule is Monday through Friday, starting at 11:30 a.m. and restoral by 8:30 p.m.

Cooling systems on the dual fuel program are cycled on and off every 15 minutes during an energy management event. The cycling timeframe is 1:45 p.m. to 6:30 p.m. on a peak alert day.

How many peak alerts can I expect throughout the summer? Summer peak alerts are issued in June, July, and August. You can anticipate at least one peak alert per month, but not more than four. Historically, peak alerts have been issued on weekdays only.

How do I know if a peak alert has been issued?

If you're unsure of your control status go to www.jackelec. com, click Residential Energy Management towards the bottom of the home screen, and view your corresponding load class (located on your monthly billing statement).

Peak alerts are announced on WWIS radio, WAXX affiliated stations, and posted on Jackson Electric's Facebook page. You can also enroll in energy management notifications by downloading the form from our website or requesting a form from our office.

What Can You Do?

To help control the wholesale power costs to Jackson Electric, we ask that you shift non-essential electrical consumption to before 11 a.m. or after 7 p.m., Monday-Friday. This may be as simple as throwing in a load of clothes in the morning and letting them line dry or running the dishwasher later at night. You may not see the direct impact of your actions, but you will be making a difference. By shifting your energy usage to a different time, Dairyland Power is buying that electricity at a lesser rate than times of high demand. This passes down to you, the member, over time by keeping electric rates stable. Jackson Electric has not had a residential rate adjustment since 2012.

SQUEEEAL ON IN TO LEROY'S GRILL

"Moving around in a food truck is hard," Tonia shares. "We were driving around hundreds of miles a week to pick up products because we couldn't receive deliveries. We also now have room here to store inventory."

Leroy's Grill is a barbeque venue that started out with pulled pork as the main cuisine. "Everyone loved it, so we

evolved and went into brisket, ribs, and smoked sausage," Tonia shares.

Pork and brisket sandwiches, BBQ plates, ribs, burgers, chicken wraps, and the sides to go along with them, such as creamy coleslaw and smokehouse beans, can all be found on today's menu. "My favorite is The Memphis. I recommend this one if you like creamy coleslaw," shares Tonia. "I prefer anything with the brisket," Leroy adds.

Leroy's is your true family-owned and operated business. Whether you drive your vehicle out to Leroy's Grill or stop in while you're out on a trail ride, you're sure to see Leroy at the counter and Tonia in the food truck preparing your order. "We have three part-time employees that help run orders out to customers and keep the dining room stocked and clean," shares Tonia.

Did you catch that Tonia would be in the food truck? Leroy's Grill has a unique setup, incorporating the original food truck into the redesign of the building. The food truck still functions as a kitchen, while the building and outside patio serve as the dining room. "We're open seasonally because of the trailer, which we cannot operate in freezing conditions," Tonia explains.

The current setup has improved business because there's a place for people to eat, even if it's raining or the weather is bad. In fact, the response to the new location has been so great that Leroy and Tonia have plans to expand their dining room to provide additional seating. "We want everyone to know we appreciate the welcome and business," shares Leroy. "It's such a wonderful community. We've since joined the Black River Falls Downtown Association and ATV Club to get more involved," adds Tonia.

In addition to great food, you'll notice artwork inside and out at Leroy's, starting with the LP tank as you enter the driveway to the mural on the wall in the dining room. "I wanted to try to make the environment fun and happy," Tonia shares.

Leroy's Grill has recently gained attention nationally. "We just found out we are invited to the Grand National Barbeque Cookoff in Texas next February," says Tonia. "It's an invite-only event and an honor to be selected."
